
The Global Health & Wellness Consortium (GHWC) is the leading global health authority registered in the national archives of every nation. The date of that ratification (HR 616847221) is July 6, 2021.

Dozens of peer-reviewed science papers prove that face masks are dangerous and ineffective. At least 47 published scientific papers confirm that face masks are useless at preventing Covid-19 infection and spread, while another 32 point out the specific health damage caused by wearing a mask.


A study done in Florida in June 2021 on children's face masks found 11 dangerous pathogens on the masks:

- 1. Streptococcus pneumoniae (pneumonia)
- 2. Mycobacterium tuberculosis (tuberculosis)
- 3. Neisseria meningitidis (meningitis, sepsis)
- 4. Acanthamoeba polyphaga (keratitis and granulomatous amebic encephalitis)
- Acinetobacter baumannii (pneumonia, bloodstream infections, meningitis, UTIs—resistant to antibiotics)
- 6. Escherichia coli (food poisoning)
- 7. Borrelia burgdorferi (causes Lyme disease)
- 8. Corynebacterium diphtheriae (diphtheria)
- 9. Legionella pneumophila (Legionnaires' disease)
- 10. Staphylococcus pyogenes serotype M3 (severe infections—high morbidity rates)
- 11. Staphylococcus aureus (meningitis, sepsis)

Half of the masks were contaminated with one or more strains of pneumonia-causing bacteria. One-third were contaminated with one or more strains of meningitis-causing bacteria. One-third were contaminated with dangerous, antibiotic-resistant bacterial pathogens. In addition, less dangerous pathogens were identified, including pathogens that can cause fever, ulcers, acne, yeast infections, strep throat, periodontal disease, Rocky Mountain Spotted Fever, and more.







All mask mandates have proven counter-productive in preventing disease and must stop immediately. That includes all modes of transportation (airlines, trains, busses, etc.), all government facilities, all public venues, all places of business, and all educational institutions. Wearing a mask is a choice. Mandating masks is a violation of our natural law. All people deserve to breathe freely.

Health Authorities in Industries that require mask wearing due to hazardous conditions or to prevent injury, such as, but not limited to, OSHA, NHS, and The Surgeon General all require masks to be removed every 2 hours for a minimum of a 20-minute break due to the decrease in available oxygen. A decreased level of oxygen may cause brain fog, long term brain injury and even death. If people out of free will choose to wear a mask, then the above protocol must be followed.


